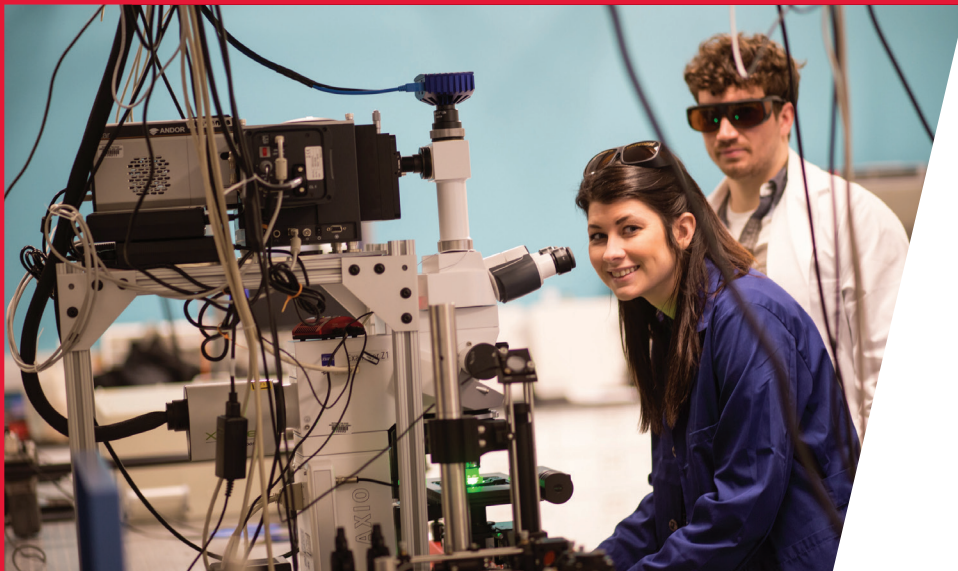

REPORT OVERVIEW

Outcomes information was gathered for **433** (33%) of the **1,314** undergraduates from the Class of 2017.

- **95%** employed full- or part-time or enrolled in graduate or professional school

SALARY INFORMATION

Overall salaries for Arts & Sciences graduates ranged from \$25,000 to \$80,000.

The average salary is \$42,983; the median salary is \$42,000.
